#### 1. Introduction

This document forms the Qualifying Explanatory Statement (QES) that supports the Declaration of Achievement of carbon neutrality for The Frontline Organisation in conformance with PAS 2060: 2014 other party validation requirements.

The Frontline Organisation has quantified their GHG emissions (Scope 1, 2 and relevant Scope 3 categories) for 2021 (See Table 1) in accordance with the World Resources Institute (WRI) GHG Protocol, a GHG assessment standard approved by PAS 2060: 2014.

It is to be noted that 2021 is the first application period<sup>1</sup> for The Frontline Organisation, which enables entities to declare their achievement of carbon neutrality solely based on offsetting.

Credits amounting to a total of 35 metric tons Carbon Dioxide equivalent (tCO₂e) were purchased by The Frontline Organisation for offsetting Scope 1, 2 and 3 emissions for 2021.

These offsets purchased were verified according to the Verified Carbon Standard and satisfy all the requirements of PAS 2060: 2014.

# New initiatives, to support achievement of GHG reductions include:

- We are continuing to monitor our usage and aim to have an external audit carried out annually.
- Expand our assessment to cover all scope 3 activities by the end of 2022
- Include satellite offices (Birmingham & Newcastle) by the end of 2022
- Long-term hybrid working models requiring less office-based work.
- We continue to use a zero to landfill approach and offer recycling throughout the building.

Carbon offsets equivalent to 35 tonnes, more than the Group's scope 1 and 2 emissions for 2020, were purchased from a Gold Standard certified scheme (GS ID GS3547) on 26/07/2022.

This offset supports the 20 MW Biomass Power Project in Chhattisgarh, India (detailed in Project Appendix).

Gold Standard VER (Verified Emission Reduction) projects provide additional social and community benefits in addition to high quality carbon offsetting. Great for individuals wanting to go further than just offsetting and perfect for businesses with ambitious CSR targets.

The offset strategy to be adopted to meet the achievement to carbon neutrality element of PAS 2060. This should include:
